#### **Ph.D. Degree Admissions Notification- JULY 2025 Batch**

**Sub:** Ph.D. Degree Admissions Notification- July 2025-Batch

**Ref:** Hon'ble Vice Chancellor's approval dated 23-05-2025

CMR University (CMRU) invites applications for the full-time with fellowship /part-time Ph.D. Degree Program in the following Disciplines:

*Management, Law, Computer Applications, Computer Science, Data Science, Computer Science & Engineering, (Artificial Intelligence, Machine Learning, Networking and Cloud Computing, Data Analytics, Cyber Security, Data Science and Internet of Things.) Electronics & Communication Engineering, Interdisciplinary Studies, Mechanical Engineering.*

#### **Eligibility:**

For Admission to Ph.D. Degree full-time with fellowship /part-time Ph.D. Degree Programme, applicants must fulfill the following criteria:

##### 1. Candidates who have completed:

A 1-year / 2-semester master's degree programme after a 4-year/8-semester bachelor's degree programme or a 2-year/4-semester master's degree programme after a 3-years bachelor's degree programme or qualifications declared equivalent to the master's degree by the corresponding statutory regulatory body, with at least 55% marks in aggregate or its equivalent grade in a point scale wherever grading system is followed.

or equivalent qualification from a foreign educational institution accredited by an assessment and accreditation agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country to assess, accredit or assure quality and standards of the educational institution.

A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/Differently-Abled/ Economically Weaker Section (EWS), and other categories of candidates as per the decision of Commission from time to time.

Provided that a candidate seeking admission after a 4-year/8-semester bachelor's degree programme should have a minimum of 75% marks in aggregate or its equivalent grade on a point scale wherever the grading system is followed . Those candidates should obtain their qualifying degrees from reputed institutions of National Importance/ NIRF ranking with in 200.



A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/Differently-Abled/ Economically Weaker Section (EWS), and other categories of candidates as per the decision of committee from time to time.

2. Candidates who have completed the M.Phil., programme with at least 55% marks in aggregate or its equivalent grade in a point scale wherever grading system is followed or equivalent qualification from a foreign educational institution accredited by an assessment and accreditation agency which is approved, recognized or authorized by any authority, established or incorporated under a law in its home country or any other statutory authority in that country to assess, accredit or assure quality and standards of educational institutions, shall be eligible for admissions to the Ph.D. Degree programme. A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/differently-abled/ Economically Weaker Section (EWS), and other categories of candidates as per the decision of committee from time to time.

**Procedure for Admissions:**

CMR University admissions to the Ph.D. Degree programmes (Full Time and Part-Time) shall be made using the following methods:

1. CMR University will admit students through an Entrance Test conducted at the level of CMR University. The Entrance Test syllabus shall consist of 50% of research methodology, and 50% shall be subject specific. However, Candidates qualified for fellowship in UGC-NET (including JRF)/ UGC - CSIR NET (including JRF)/SLET/GATE/CAT & GMAT (only for management candidates)/ Teacher Fellowship holder and similar National level tests will be exempted from the Entrance Test.
2. Students who have secured 50% marks in the Entrance Test are eligible to be called for the interview.
3. A relaxation of 5% marks will be allowed in the entrance examination for the candidates belonging to SC/ST/OBC/differently-abled category, Economically Weaker Section (EWS), and other categories of candidates as per the decision of the Committee from time to time.
4. CMR University will decide the number of eligible students to be called for the interview based on the number of Ph.D. Degree seats available.
5. Provided that for the selection of candidates based on the entrance test conducted by the University, a weightage of 70% for the entrance test and 30% for the performance in the interview/viva-voce shall be given.
6. The personal interview/viva voce shall consider the following aspects:
  - a) The relevancy of the proposed area of research;
  - b) The candidate possesses the competence for the proposed research;
  - c) The research work can be suitably undertaken at the respective school of studies.
7. The final list of selected candidates will be announced and they are eligible to take admission to the Ph.D. Degree program in the concerned fields of specialization. The number of candidates selected shall depend on the existing vacancies under different disciplines and respective supervisors.



### **CMRU Fellowships:**

Full-time scholars admitted to the program are eligible to apply for the CMRU fellowship schemes under JRF/SRF. The monthly stipend for eligible candidates is up to Rs. 35,000/-.  
(1<sup>st</sup> and 2<sup>nd</sup> year: Rs. 30,000/- 3rd year: Rs. 35,000/-)

### **Instructions for Applicants:**

- The applicants are requested to fill up the Online Application form available on the CMR University website ([www.cmr.edu.in](http://www.cmr.edu.in)). Application fee of Rs 1500/- shall be paid online.
- The vacancies in various disciplines for Ph.D. Degree admission in July 2025 are available on the CMRU website, for details please refer to [www.cmr.edu.in](http://www.cmr.edu.in).
- The duly filled application along with the copies of educational transcripts and photo ID proof along with a copy online receipt shall be submitted at the office. The application fee paid is non-refundable and non-transferable.
- The last date to submit the application form is **Monday, 30<sup>th</sup> June, 2025**
